MAYORAL VETO ISSUED 12/09/21 for PZ 21-036

Under Section 2.33 of the Charter for the City of Powder Springs, the Mayor exercised the Mayoral veto within four (4) business days after the meeting of the Council in which to file with the City Clerk his veto in writing. The veto was issued for the following reasons by Mayor Thurman:

1. Per the requirements of the UDC, if the City Council's denial remains in effect, no rezoning

or special use application affecting the same or any portion of property which was denied by the City Council can be accepted for filing by a property owner until 12 months shall have elapsed from the date that the application was denied. As there is a substantial interest in developing a unified development plan for the area in the near future, a veto will avoid the 12-month prejudice period.

2. Similarly, avoiding the 12-month prejudice period retains the possibility that the Development Authority of Powder Springs can proceed with a Request for Proposals for the city owned property, as well as the other parcels across the street, for a partner to develop a project more in line with the potential redevelopment ideas embodied in current draft of the City's Comprehensive Plan.

Under Section 2.33 of the Charter the Council may within thirty days pass any such ordinance, order or resolution, notwithstanding the veto, by an affirmative vote of four (4) Council members.

5. Executive Session, if called for purposes of Real Estate, Litigation or Personnel Matters

6. Adjournment

Following adjournment of Council Meetings, the Mayor and various Council Members often remain at the City Hall meeting room podium to sign ordinances, resolutions and contracts, greet and speak with citizens, and discuss current events. To the extent this activity may be considered a meeting under the Georgia Open Meetings Law, the public is hereby notified thereof, and invited to attend.
