RES0 16-047 Resolution – Authorize Mayor to Execute Contract with Bartow Paving – 2016
LMIG - \$369,271.04

The City applied for and was awarded funding assistance from the state to complete resurfacing of Oglesby Road, Thornbridge Drive, Childress Drive and Carrington Park Drive. Upon notice of award, the City sought and obtained bids for the resurfacing. Bartow Paving Company was the lowest responsive bidder.

Resolution – Janitorial Services - Bonus Building Care - \$2295 monthly amount for stated facilities (\$27,540 annual amount). The City requested and received bids to clean city-owned facilities, and Bonus Building Care was the lowest responsive bidder. In order to enable the Facility Maintenance Supervisor to select unforeseen but necessary additional services, the approval includes an additional sum up \$32,000

Resolution - Building Services Contract - SAFEbuilt

The City has an existing contract with SAFEbuilt Georgia Inc. for building department and code enforcement services. The contract authorizes an annual extension of 12 months. This resolution renews the contract for 12 months for building department services but excludes code enforcement services, which will be brought in-house. The building department service is paid with permit fees. There are no increases in permit fees.

Resolution - Renewal of Grounds Maintenance and Mowing Contract - TruGreen Landcare - \$112,677.

The City has an existing contract with TruGreen for mowing and maintenance of various areas throughout the City, including a portion of the areas mowed by previous inmate labor that is no longer available. The contract provides for three one-year extensions. This approval will be the 3rd extension.
