### City To Continue Residential Growth

Powder Springs City Council members at the March 21 meeting greenlit three residential developments in their unanimous approval of rezoning requests, including one following an annexation of about 33 acres.

The largest residential project will consist of up to 105 single-family homes on nearly 38 acres at Austell Powder Springs Road, Dugger Drive, Smith Drive and Frank Akin Road. About 4 acres of the development were already within the city, with the remaining portion of the land now expanding the city limits. Council members approved the annexation request related to the development before going on to approve overall rezoning of the total tract to the Planned Unit Development-R (PUD-R) category; the city portion of the land was previously zoned residential while the county portion had included both residential and general commercial zonings.

A PUD-R rezoning was also approved for 4385 Walton St. Previously zoned under the R-15 residential category, the approved zoning change will allow for construction of 12 townhomes.

Another 70 residences, consisting of 42 townhomes and 28 detached homes, were given the go-ahead to proceed on an estimated 11.5 acres at 5592 Powder Springs Dallas Road. The project's developer will contribute \$70,000 to improve a right-turn lane onto C.H. James Parkway as part of the approved stipulations.



## Keep Those Yards in Check

Powder Springs Code Section 10-21 says: "Every person or entity owning or occupying improved or unimproved property within the city shall at all times maintain such property in a clean and sanitary condition which shall include, but not be limited to, keeping the property free from all waste, litter, trash, dead animals and rubbish of every nature and kind. In order to prevent the property from becoming a breeding ground for vermin and other types of pests **the property shall also be kept free of weeds, underbrush and high grass more than eight (8) inches in height.**

If you receive a code violation warning notice related to this or other matter, you must correct the violation by the date shown on the notice. If you are unable to correct the violation within the time given, call the Quality of Life Officer to discuss the violation. Only one Warning Notice for a particular violation will be issued within a 12-month period. Repeat occurrences of the same violation within the 12-month period will result in immediate issuance of a citation.



A citation is a summons to appear before the judge at City Municipal Court. You are required to appear at court on the date and time shown on your citation. If you have any questions, contact the Code Enforcement Officer at 770-943-1616, x203.

## Sanitation Bills Due May 16

The City of Powder Springs bills quarterly for sanitation and lights. Payments must be made by May 16. If accounts are unpaid at that time, sanitation carts will be picked up and returned once the account is paid in full. The balance will include a return-cart fee. Please mark your calendars to pay your bill before May 16.

Upcoming dates to remember:

- Good Friday (April 15): Friday routes will be collected on Monday, April 18. No yard waste collection the week of April 18. Yard waste collection will resume Monday, April 25.
- Memorial Day (May 30): No yard waste collection the week of May 30. Yard waste collection will resume on Monday, June 6.
- Independence Day (July 4): No yard waste collection the week of July 4. Yard waste collection will resume on Monday, July 11.
