The event sponsor Caterer shall be required to provide proof of alcohol beverage liability insurance in an amount equal to a minimum of \$1,000,000 and which shall name the City of Powder Springs as additional insured thereon.

The event sponsor shall be required to execute a Hold Harmless and Indemnification Agreement in a form acceptable to the City wherein the event sponsor shall agree to hold harmless and indemnify the City of Powder Springs from and against any and all liability, costs including attorney's fees, expenses, damages, suits, judgments and expenses arising from the event.
